# COVID-19 PUBLIC SERVICE ANNOUNCEMENT REGARDING REINVESTMENT TASK FORCE MEETING ACCESS AND PUBLIC COMMENT

Until further notice, Reinvestment Task Force (RTF) meetings will be conducted pursuant to the provisions of <u>California Executive Order 29-20</u>, which suspends certain requirements of the Ralph M. Brown Act.

During the current State of Emergency and in the interest of public health and safety, most—and most likely all—of the RTF Members and staff will be participating in RTF meetings by teleconference. In accordance with the Executive Order, there will be no members of the public in attendance at the RTF meetings. The RTF is providing alternatives to in-person attendance for viewing and participating in RTF meetings.

#### ITEM 7 Information Item: Homeownership Focus Group Findings

The WORTH homeownership collaborative undertook an environmental scan and needs assessment process prior to developing the WORTH plan (Item 8). It contracted with MAAC Project's evaluation professionals to develop a research methodology and conduct focus groups to identify barriers and opportunities to local minority homeownership from the perspective of those who are closest to the issue. MAAC's team will present the findings from several listening sessions held with financial counselors, real estate brokers and potential homebuyers.

#### ITEM 8 Information Item: WORTH Homeownership Plan

As previously discussed, the RTF is helping lead the development of a strategic, community-centered four-year plan to narrow the racial wealth gap by increasing local homeownership among consumers who are Black, Indigenous and People of Color (BIPOC). Creation of the highly-tactical plan has been funded by a national Wells Fargo Wealth Opportunities Restored Through Homeownership (WORTH) grant and led by a collaboration that includes LISC, MAAC Project, Logan Heights CDC, the Housing Commission's First-Time Homebuyer Program and Achievement Academy, Housing Federation, Urban League, City Council District 4, and the national Black and Hispanic real estate organizations, NAREB and NAHREP.

The WORTH homeownership collaborative and staff will brief the RTF on the collaborative's work and share an overview of the final plan and related grant application for Wells Fargo, due on March 31. Completion of the plan qualifies the collaborative to compete for \$7.5 million in implementation funding.
