# ITEM 6 <u>Information Item: Housing Affordability Crisis Action Plan</u>

The Housing Commission's Wendy DeWitt presented recommendations from <u>Addressing the Housing Affordability Crisis: Action Plan for San Diego.</u> The recent Commission report seeks to identify the root causes of the high cost of developing, rehabbing or preserving affordable rental housing in San Diego. The Commission hopes that identifying cost drivers will lead to solutions that ultimately increase the production of affordable housing, a goal of nearly all of the RTF's members.

The report includes 11 recommendations for lowering the identified costs, such as introducing tax rebates and exemptions to encourage 80/20 developments in which 80% of units are at market-rate and 20% are affordable, reducing requirements on developers to include commercial space in multifamily complexes, opening more vacant or underutilized land for development, and setting annual goals for housing production and tracking progress in meeting the goals.

City staff are working with SDHC to explore the potential for crafting the recommendations into City ordinances or action at the Federal or State level. Senior Commission staff have also begun sharing the report's findings with Sacramento policymakers and other audiences.
