ITEM 6 Information Item: Building Self-Employment and Family Wealth Through Food-Related Small Businesses

The RTF will hold a listening session on the challenges, needs and success stories of microentrepreneurs who've started food-based small businesses as a way to create income, jobs and family wealth. Speakers from community-based small businesses, cafes and neighborhood organizations will share personal stories and present case studies illustrating a variety of experiences. The presentations will help inform RTF discussion of the needs of start-up businesses in underserved communities, and how RTF members and the broader community can support microbusiness sustainability, growth, and successful acquisition of loan capital.

ITEM 7 Information Item: 2019 Free Tax Prep Project Wrap-Up

RTF staff and representatives from the San Diego Earned Income Tax Credit (EITC) Coalition will report out on the outcomes, metrics, and final participation numbers from this year's tax program, which worked to expand access to free tax preparation services and improve update of the federal and state Earned Income Tax Credit by low and moderate-income individuals and families, increasing their state and federal tax refunds and providing significant savings on professional tax preparation services.
