COVID-19 PUBLIC SERVICE ANNOUNCEMENT REGARDING REINVESTMENT TASK FORCE MEETING ACCESS AND PUBLIC COMMENT

Until further notice, City-County Reinvestment Task Force (RTF) meetings will be conducted pursuant to the provisions of [California Executive Order 29-20](#), which suspends certain requirements of the Ralph M. Brown Act.

During the current State of Emergency and in the interest of public health and safety, most—and most likely all—of the RTF Members and staff will be participating in RTF meetings by teleconference. In accordance with the Executive Order, there will be no members of the public in attendance at the RTF meetings. We are providing alternatives to in-person attendance for viewing and participating in RTF meetings.

If you have an attachment to your comment, you may send it to rtf@sdhc.org and it will be distributed to the RTF Members. Only comments submitted no later than 12 noon the day of the meeting using the public comment webform will be eligible to be read into the record. If you submit more than one form per item, only one will be read into the record. Comments submitted after 12 noon the day of the meeting but before the item is called will be submitted into the written record for the relevant item. All comments are limited to 1,250 characters (approximately 200 words).

ITEM 6 Information Item: Measure A – City of San Diego Affordable Housing Bond

The City of San Diego is attempting to follow in the footsteps of San Francisco and Los Angeles with a ballot measure to raise public funds for constructing affordable housing. Staff from the Affordable Housing Federation will explain the November ballot's Measure A, which would generate up to \$900 million for local affordable housing through general obligation bonds paid off by a property tax assessment.

[Mapping Inequality](#) is the product of a multi-university collaborative that recently digitized and georeferenced the original Federal Home Owners Loan Corporation maps and categories that provided the origin of the term *redlining*. LISC San Diego has compiled San Diego's maps into an accessible online [publication and research tool](#) that LISC staff will explain and show to the RTF.

ITEM 8 Roundtable Discussion Item: Update on Economic Impacts of Covid-19 Pandemic

The RTF's members from government, nonprofits and financial institutions will report on what challenges, changes and assistance their organizations are seeing in the community, what interventions and policies have helped residents and small businesses the most, what needs are still urgent, and what changes and outcomes members and their organizations foresee in the coming months.

ITEM 9 Roundtable Discussion Item: November CRA Survey Report & Format

At its upcoming November 5 meeting, the RTF will share results and analysis of its annual survey of RTF financial institutions' Community Reinvestment Act activity. This annual report collects data on the volume and value of CRA-related loans, investments and grants issued by the RTF's six large bank members in the prior year. In order to continually improve the readability and usefulness of the annual report, RTF members will discuss the prior years' report and what changes or additions could further improve understanding and inform the creation of solutions to increase reinvestment throughout San Diego County.
