ITEM 7 <u>Information Item: Local Impact of Federal Executive Orders</u>

Nonprofit, business and governmental organizations are quickly adapting plans and trying to understand the implications of myriad executive orders, policies and actions flowing from Washington, D.C. The philanthropic organization Catalyst has been tracking local impacts in the nonprofit, community development and foundation spheres and sending out weekly updates. Catalyst staff will share what they're seeing, followed by government representatives and all of the RTF members, who will report out on impacts so far to their budget, clients and to underserved communities, and the resulting pivots on services, grants, employment and strategic planning that their organization and partners are making.

ITEM 8 Action Item: RTF Legislative Platform and Program

At the November RTF meeting, co-chairs' staff presented a framework for creating an RTF legislative platform and program similar to such programs at other jurisdictions, from the City and County to MTS. Since then, staff have met with stakeholders and partners to identify priority advocacy areas and develop the RTF's plan, including procedures for engaging on specific issues and sending letters of support. The creation of a list of state, local and federal issues that the RTF supports will provide members and partners with a tool for to aligning advocacy work in pursuit of joint goals when speaking to legislators and other policy makers. The platform will also reiterate the RTF and its members' support for the core principles, goals and mission of the Community Reinvestment Act, which was the founding purpose for the RTF's creation. RTF members will vote at the meeting on the Reinvestment Task Force's Legislative Platform, with its list of priority issues, and processes for conducting advocacy, considering new issues, and deciding whether and when to write or sign onto support letters.
