2025-2026 STATE and FEDERAL LEGISLATIVE PLATFORM

The 2025-2026 State and Federal Legislative Platform defines the City of San Diego's Guiding Principles and Policy Priorities and provides a means to advance and protect the City's interests on issues at the federal and state levels. The Guiding Principles and Policy Priorities allow for flexibility so that Government Affairs, City officials, and our legislative advocates can be proactive and quickly respond within the defined boundaries of the program to address legislative, regulatory, administrative, and budgetary issues that arise during the year.

In pursuing the Policy Priorities reflected below under the categories of: Homelessness, Housing Affordability, & Community Services; Sustainability, Environmental Quality, & Infrastructure; Economic Development, Tax, Trade, & Immigrant Affairs; Governance, Transparency, & Revenue; Public Safety; Veterans Affairs; and Workforce Development, Education, & Youth Opportunity. The Guiding Principles are as follows:

PROMOTE SOCIAL JUSTICE, EQUITY, AND INCLUSIVE ECONOMIC DEVELOPMENT

Strive for the furtherance of social justice, equity, and inclusive economic development to promote fairness and empowerment for all people and communities, including marginalized populations. Support legislation and funding that expands opportunity and access to education, healthcare, housing, employment, and clean air and water, and increases cultural competency and language access capabilities of government to enhance civil liberties and equal opportunity. Aim to eliminate prejudice and disparities based on sex, gender identification, ethnicity, race, nationality, age, religious or spiritual beliefs, sexual orientation, legal status, language, veteran or socioeconomic status, or physical ability.

PRESERVE LOCAL CONTROL

Preserve and protect the City's charter powers, duties, and prerogative to enact legislation, to provide policy direction concerning local affairs, and to oppose legislation that preempts local authority. Local agencies should preserve and enhance authority for revenues raised and services provided.

SUPPORT FISCAL STABILITY AND FUNDING OPPORTUNITIES

Support measures that promote fiscal stability, predictability, and financial independence, and that preserve the City's revenue base and local control over municipal government budgeting. Oppose measures that make the City more dependent on other governments for financial stability, such as unfunded mandates or shifting of local funds to other levels of government. Support efforts that create new, or increase the City's competitiveness for existing, funding opportunities including both direct funding and grant opportunities available to both public and non-profit partner organizations or businesses which advance City's policy priorities.

POLICY PRIORITIES:

1. HOMELESSNESS, HOUSING AFFORDABILITY, & COMMUNITY SERVICES

State

1. Support measures that provide economic recovery efforts, that can assist residents regardless of their immigration status, including direct assistance for individuals, funding to protect and house persons experiencing homelessness, rent relief for residential and commercial tenants, eviction moratoria, borrower relief for impacted homeowners, unemployment assistance and small business relief, and support for local governments.
2. Pursue new and preserve established state resources, including the Homeless Assistance and Prevention Program, for City homelessness programs including but not limited to permanent supportive housing, recovery housing, transitional housing, emergency shelter, and other city homeless programs, flexible subsidy pools like rapid rehousing, homelessness prevention and diversion, outreach, and rental assistance, and support measures for an ongoing funding source.
3. Support measures that enhance and reform the Lanterman-Petris-Short Act, CARE Act, Behavioral Health Services Act, Laura’s Law, and conservatorship laws to provide cities and local governments better legal tools that allow local governments, health providers, and law enforcement to help people access behavioral health treatment more effectively, especially when individuals are unable to provide for their basic personal needs.
4. Support legislation that reduces regulatory barriers and enhances flexibility toward the creation and permitting of emergency housing interventions including, but not limited to, non-congregate shelters, safe havens, bridge shelters, safe parking, and safe storage programs.
5. Pursue resources made available by the Building Jobs and Homes Act, and support measures that enhance San Diego’s flexibility to use this funding.
6. Support measures that maximize the use of evidence-based practices within Proposition 63 Behavioral Health Services Act funding in the San Diego region, and that collaborate with the Mental Health Oversight and Accountability Commission and local stakeholders.
7. Support legislation, including efforts through the Assisted Living Waiver, CalAIM, and BH-CONNECT proposals, that enhances health outcomes for persons with cognitive, mental health and substance use disorder needs through streamlining and standardizing Medi-Cal delivery, modernizing systems, payment reform, and better management of member risk and needs, including in-lieu services to facilitate transitions to permanent housing.
8. Support legislation that promotes the retention and expansion of inpatient, Assertive Community Treatment (ACT) teams, Mental Health Rehabilitation Centers, skilled nursing facilities, chemical dependency recovery hospitals, neurobehavioral units, respite care, recuperative, residential rehabilitation, withdrawal management and long-term mental health facilities and services, as well as ongoing resources to improve network adequacy and overall health outcomes.

9. Support measures that encourage community-based behavioral health service delivery models for individuals that frequently use emergency services, including partnerships between Emergency Medical Technicians and psychiatric clinicians, including support for 5150 authority for specially trained city emergency personnel.
10. Support state actions to pursue federal waivers to expand eligibility for Medicaid reimbursement for services, including those provided through facilities deemed to be Institutions for Mental Diseases.
11. Support legislation, financial assistance, and regulatory action to prevent communicable disease, public health risks, and address water quality impacts.
12. Support legislation that promotes infill housing production while reducing vehicle miles traveled, in line with local and state policies on coastal zones, historic resources, and wildfire risk mitigation.
13. Support legislation that enhances the City's ability to access funding and incentives for affordable and accessible housing for all economic impacted members-of the community including people experiencing homelessness seniors, people with disabilities, veterans, refugees, artists and low-and-moderate households.
14. Support measures that promote the use of public land for housing, including affordable and middle-income housing.
15. Support legislation that would amend the State Surplus Land Act to clarify that not all public land is suitable for housing, particularly where development would conflict with the City Charter or voter-approved measures, including, but not limited to, dedicated public parkland such as Mission Bay Park, Balboa Park, Mission Trails Regional Park, other regional parks, open space, or canyons.
16. Support legislation that would amend the State Surplus Land Act to exclude Mission Bay Park.
17. Support measures that promote the use of public land for housing, including affordable and middle-income housing," and remove the language "and streamline Surplus Land Act processes to enhance the viability of housing projects on public land.
18. Support measures that enhance the viability of housing through community land trusts.
19. Support legislation that promotes housing production through conversions of vacant commercial and office properties, and single room occupancies.
20. Support legislation, regulations, and resources that preserve deed restricted affordable housing and naturally occurring affordable housing.
21. Support legislation that provides more local and state streamlining and incentives for cities to meet their housing goals and that benefit cities with pro-housing policies, including measures that streamline and provide funding resources for hotel and retail site conversions to incentivize more housing.
22. Support legislation that promotes neighborhood investment through mixed income housing to incentivize economic development in low-to-moderate income communities while mitigating displacement.
23. Support funding and policies that promote the development of middle-income housing.
24. Support legislation and enhanced funding for parks, recreation, arts, public restrooms, and public libraries including broadband internet access, capital improvements, and programs with a focus on making these community services more equitable by increasing investment in historically disadvantaged communities.

25. Support legislation and enhanced funding for direct funding to artists and nonprofit arts and culture organizations from agencies including the California Arts Council and enhanced funding directed to municipalities such as San Diego for support of community-wide access to arts and culture through programs and partnerships.
26. Support efforts that benefit and provide community benefits in areas designated through the Federal Promise Zone program.
27. Support added flexibility in providing reimbursement for Medi-Cal eligible health services across managed care, specialty behavioral health, and substance use disorder treatment health plans to enhance overall health outcomes.
28. Support homelessness prevention efforts, including those that further protect against housing discrimination, including income and lack of credit history.
29. Support efforts that support and enhance food security and food access, including land use and regulatory reforms that streamline or incentivize grocery stores and community gardens, and opportunities to provide food access through city facilities like recreation centers.
30. Support and promote legislation to incentivize and streamline the process to increase the accessible housing supply for people with disabilities.
31. Support efforts and resources that advance anti-displacement efforts and relocation assistance, as well as legal education and resources around housing law.
32. Support legislation and regulatory action that assists with housing production and provides resources for housing at the moderate-income level, including changes to building standards and construction methods, and provides more flexibility in the use of prefabricated and modular home construction and mass timber.
33. Support legislation to reduce the voter threshold for ballot initiatives to fund affordable housing and infrastructure to 55%.
34. Support legislative efforts and resources to implement the recommendations of the Task Force to Study and Develop Reparation Proposals for African Americans established under AB 3121.
35. Support legislative efforts and resources that expand the ability for local agencies to utilize social housing and public banking.
36. Support measures that protect and augment reproductive healthcare rights, including those that protect data and privacy of patients, and oppose measures that limit availability of those healthcare options and rights.
37. Support legislation that would create statewide construction loan guarantee programs to reduce risk and uncertainty in the construction process and promote homebuilding.
38. Support legislation and resources for homeownership, including first time homebuyer programs, and ensuring housing production legislation contemplates home ownership models.
39. Support legislation and regulatory action that incentivizes the construction of family units, including potential updates to Housing Element Law to account not just for number of units, but number of people housed.
40. Support dedicated state funding for conservatorship oversight.
41. Support legislation, funding, and regulatory streamlining that allow for more timely and efficient abatement of encampments on Caltrans Right of Way.

42. Support legislation that requires local governments with an unsafe camping or prohibitive camping ordinance to prioritize the building of shelter or risk losing state resources.
43. Support efforts to reform the state insurance markets to address the ongoing insurance affordability crisis and assist with bringing insurers back to the state.
44. Support legislation, funding, and regulatory changes that assist homeowners and HOAs for hardening their property rather than being charged equally because they are in proximity to natural open space.
45. Support legislation that amends the California State Building code to allow for the potential use of single stair multifamily housing buildings.
46. Support legislation that eliminates California's condo defect which discourages the development of new multifamily housing for ownership.
47. Support legislation and funding that assists seniors from falling into homelessness.
48. Support legislation, funding, and regulatory streamlining that assist local governments in operating tiny and modular homes.
49. Support legislation that advances funding for a statewide housing bond to support the develop of affordable and interim housing.
50. Support previously introduced SB 1462 that will reduce financing costs and risks for new condominium projects by allowing developers to use deposits made by buyers during the pre-sale process to cover construction costs.
51. Support legislation that directs funding for affordable housing to be prioritized in moderate, high and highest resource areas as determined by the CTCAC Opportunity Area maps.
52. Support legislation that promotes affordable housing production and ensures fair labor practices.
53. Support efforts at the intersection of healthcare and homelessness that maximize use of evidence-based practices within Proposition 1 funding in the San Diego region, including Homekey+.
54. Provide tax relief such as a deferral or exemption from state and local real estate taxes, to assist property stabilization and preservation.
55. Support funding or the physical preservation of deed-restricted properties to perform adequate and timely capital improvements of building and property systems.
56. Support financial incentives for the acquisition of apartment buildings for preservation.
57. Support non-profits efforts to acquire new properties and preserve affordability covenants.
58. Support measures and funding that promotes affordable housing for artists.

Federal

1. Support efforts to increase Federal Rental Assistance by increasing and extending funding for additional Housing Choice Vouchers, Project Based Vouchers, Stability Vouchers, and Emergency Housing Vouchers.
2. Support measures that provide for economic recovery efforts, that can assist residents regardless of their immigration status, including direct assistance for individuals, funding to protect and house persons experiencing homelessness, rent relief for residential and commercial tenants, eviction moratoria, borrower relief for impacted

homeowners, unemployment assistance and small business relief, and support for local governments.

3. Support increased or sustained funding and oppose cuts to the U.S. Department of Housing and Urban Development (HUD), specifically, support funding of community services and housing programs including Community Development Block Grants (CDBG), HOME Investment Partnership, Emergency Solutions Grants (ESG), CDBG PRO-Housing Grants, and housing voucher programs.
4. Support permanent increase percentage of public services funds category currently capped at 15%, increasing up to 20% or higher specifically for Community Development Block Grant to enhance the number of people served by nonprofits working with vulnerable populations.
5. Support revisions to the McKinney-Vento Homeless Assistance Grants program so funding for homeless services is allocated based on need.
6. Support measures that give Public Housing Authorities greater flexibility in administering resources, including those that preserve and expand flexibilities and waivers afforded to Moving to Work agencies.
7. Support an increase in funding for Veteran Assisted Supportive Housing (VASH) and Homeless Programs, as well as regulatory flexibility to maximize utilization of these resources, including measures that would support and fund a universal voucher program.
8. Support legislation that would provide resources for permanent supportive housing and provide funding for comprehensive supportive services, including those related to veteran affairs and behavioral health.
9. Support legislation that expands the supply of affordable housing by adopting reforms that reduce barriers to improved planning and increase the financial resources available, and that promote housing choice and further fair housing.
10. Support measures that promote the use of public land for housing, including affordable and middle-income housing.
11. Support efforts to streamline Fair Market Rent calculations to adequately reflect current rental market trends in areas such as San Diego.
12. Support efforts to reform and expand the Low Income-Housing Tax Credit and the development of additional affordable housing units, including tax credit legislation that promotes middle income housing production.
13. Support legislation that promotes neighborhood investment through mixed income housing to incentivize economic development in low-to-moderate income communities while mitigating displacement.
14. Support and monitor efforts to clarify and reform federal bank regulations to ensure compliance does not negatively impact the economic vitality of banks in border communities and ensure our border region has access to banking.
15. Support legislation and enhanced funding for parks, recreation, arts, public restrooms, and public libraries including internet access, capital improvements, and programs with a focus on making these community services more equitable by increasing investment in historically disadvantaged communities.
16. Support increased or sustained funding and oppose cuts to federal agencies that directly benefit artists and arts and culture non-profits in cities such as San Diego,

including the National Endowment for the Arts, National Endowment for the Humanities and Institute of Museum and Library Services.

17. Support legislation and enhanced funding from federal agencies directed to municipalities such as San Diego for support of community-wide access to arts and culture through programs and partnerships.
18. Support legislation which funds senior services including enhanced social and mental health services, housing, recreational programs, and transportation.
19. Support the repeal of the Institutions for Mental Diseases (IMD) exclusion.
20. Oppose any Congressional or administration action which could detrimentally impact our diverse community, particularly our immigrant and LGBT populations, or impede the City's ability to provide public safety services to our citizens.
21. Pursue opportunities related to the extension of the City's Federal Promise Zone designation.
22. Support measures that increase resources for prevention and diversion programs to assist residents at risk of being evicted, including measures to allocate rent relief resources to jurisdictions with a higher need and proven record of getting relief to tenants and landlords.
23. Support efforts that further protect against housing discrimination, including income and lack of credit history.
24. Support legislation that works to reduce college student housing insecurity through federal resources for secure temporary or permanent housing.
25. Support efforts that support and enhance food security and food access, including land use and regulatory reforms that streamline or incentivize grocery stores and community gardens, and opportunities to provide food access through city facilities like recreation centers.
26. Support and promote legislation to incentivize and streamline the process to increase the accessible housing supply for people with disabilities, especially for people with co-occurring physical and behavioral disabilities.
27. Support efforts that reduce displacement including efforts that would create funding for anti-displacement efforts, as well as legal education and resources around housing law.
28. Support legislation that assists with housing production and provides resources for housing at the moderate-income level, including changes to building standards and construction methods.
29. Support legislative efforts and resources to implement the recommendations of the Task Force to Study and Develop Reparation Proposals for African Americans established under AB 3121.
30. Support legislative efforts and resources that expand the ability for local agencies to utilize social housing and public banking.
31. Support measures that protect and augment reproductive healthcare rights, including those that protect data and privacy of patients, and oppose measures that limit availability of those healthcare options and rights.
32. Support legislation and resources for homeownership, including first time homebuyer programs for low and moderate-income households, and ensuring housing production legislation contemplates home ownership models.

33. Support reforms to the annual Department of Housing and Urban Development Point in Time Count that incorporates innovative programs to get service resistant individuals into the shelter system, such as Safe Parking and Sleeping programs, to accurately reflect the state of unsheltered homelessness.
34. Oppose efforts to make it harder to receive housing benefits.
35. Oppose funding and staffing reductions to the Department of Housing and Urban Development.
36. Oppose changes to the Continuum of Care (CoC) program that limits funding for permanent housing.
37. Support the passage of the ROAD to Housing Act of 2025.
38. Support the passage of the Cut Red Tape for Housing Act which exempts infill housing development from the National Environmental Protection Act (NEPA).
39. Oppose efforts to restrict nutrition programs that help address food insecurity, such as SNAP, WIC, etc.
40. Support legislation that attains funding for the Community Development Block Grant Disaster Recovery Program to rebuild disaster-impacted areas and provides crucial seed money to start the long-term recovery process.

2. SUSTAINABILITY, ENVIRONMENTAL QUALITY, & INFRASTRUCTURE

FOCUS 2.1: Transportation Infrastructure, Mobility, & Vision Zero

State

1. Support legislation and opportunities to improve transportation, including, but not limited to, improving traffic safety, reducing congestion, curb management, electric vehicle charging infrastructure, repairing local roads and highways, expanding trail networks, and supporting noise abatement for properties near freeways.
2. Support existing and expanded funding for local and regional transportation infrastructure including transit, bicycle, flexible fleets, accessible services, and other new regional infrastructure and technology.
3. Support legislation, funding, and programs that promote active transportation including those that increase safety, increase connectivity to mass transit to address first and last mile gaps, and allow bicycles to yield at stop signs to promote safety.
4. Support legislation, administrative action, and opportunities to increase and maximize funding and flexibility to improve mass transit and active transportation, including local and regional bicycle and pedestrian mobility and accessibility projects, road realignment, youth passes, e-bike incentives, autonomous and connected vehicle technology; transit only lanes, safety, such as Safe Routes to School and Vision Zero, airport connectivity, and infrastructure improvements.
5. Support Vision Zero programs and prioritization of discretionary funding to cities that have adopted Vision Zero initiatives.
6. Support legislation and administrative actions which ensure the City's ability to obtain a fair share of grant funding made available by the federal Infrastructure Investment and Jobs Act (IIJA)/Bipartisan Infrastructure Law (BIL) and Inflation Reduction Act

- (IRA), and the Road Repair and Accountability Act of 2017, the Greenhouse Gas Reduction Fund (GGRF), and any other state funds for which the City can compete.
7. Support legislative and regulatory efforts that increase San Diego’s competitiveness for funding based on local efforts to invest in infrastructure that reduces greenhouse gas (GHG) emissions and maximizes housing development near transit.
 8. Support legislation that would expand the use of Enhanced Infrastructure Finance Districts and Community Revitalization and Investment Authorities or would provide incentives for taxing agencies to contribute resources.
 9. Support efforts to increase funding and remove legislative and regulatory barriers for infrastructure improvements that improve connections to—and facilities around—public transit, buses, streetcars, and trolley lines.
 10. Support legislative and regulatory frameworks that reduce vehicle miles traveled through Transportation Network Companies, the taxicab industry, and shared mobility devices, while providing reasonable consumer protections and promoting the reasonable sharing and use of data for regional land use decision-making.
 11. Support legislation that would provide the City the authority to use additional contract delivery methods for infrastructure projects.
 12. Engage with agencies, such as the Department of Transportation, to clear debris on state-owned property and parcels, and support funding for these efforts.
 13. Support measures and funding to assist local jurisdictions to complete utility undergrounding.
 14. Support measures and funding that enhance the City’s ability to implement transit lanes, including allowing the use of freeway shoulders.
 15. Support legislation and resources to fund near-term stabilization of commuter rail along the Del Mar bluffs as well as long-term projects to ensure safe travel of passenger and freight.
 16. Support funding and programs that promote sustainable freight and enhance inter-city and commuter rail to benefit the San Diego region, including the LOSSAN corridor and Metrolink service in coordination with the Metropolitan Transit System and North County Transit District.
 17. Support measures to preserve and expand the City’s access to resources from the California Infrastructure and Economic Development Bank (IBank) programs to fund public infrastructure.
 18. Support legislative efforts to enhance local control to regulate and manage micro-mobility, autonomous vehicles, automated delivery devices, and rideshare.
 19. Support legislation to enhance local control over the setting of enforceable speed limits to promote safe, walkable neighborhoods.
 20. Support measures that provide more local control for aesthetic crosswalk treatments, placemaking opportunities in the right of way, and pedestrian plazas.
 21. Support legislation that authorizes local governments to use meter-less parking payment systems.
 22. Support legislation that allows local jurisdictions to implement cost-recovery measures for public bathroom access.
 23. Support legislation that allows local jurisdictions to fully realize benefits of a “one dig policy” and remove barriers so local jurisdictions can require utilities to jointly trench/underground cables.

24. Support legislation to authorize use of a right-of-way to include park and recreational uses, as well as placemaking, including private outdoor dining, so long as the right-of-way continues to provide a vehicular, transit, pedestrian, and/or bicyclist connection.
25. Support funding and programs that prioritize the creation of rebates and subsidies for electric vehicles, especially for low-income residents.
26. Support resources for road maintenance, including repaving, overlay and restriping.
27. Support legislation and funding that will create funding opportunities for repairing, rehabilitating, and rebuilding ocean-based pier infrastructure.
28. Support legislation or regulatory reforms that enhance local government's ability to expedite quick build transportation projects.
29. Support legislation and regulatory reforms that allow for local governments to conduct street narrowing to improve walkability and safety.
30. Support legislation and funding that provide support to communities to do pre-disaster mitigation activities.
31. Support legislation, funding, and programs that promote transit accessibility, including prioritizing access to wheelchair accessible vehicles and on-demand para transit options.
32. Amend the definition of coastal access to be more focused on ensuring physical access to the coast is prioritized.
33. Support legislation to assist San Diego transit agencies with long-term financial stability.
34. Support legislation and funding that convert key underutilized highways and roads in the State into multi-modal corridors to reconnect communities divided by transportation infrastructure.

Federal

1. Pursue funding opportunities for City projects created through administration and congressional infrastructure proposals, innovative financing tools, national freight transportation policy, and cross border entry financing proposals, including any and all actions that enhance the City's ability to access funding through the IJIA/BIL and the IRA.
2. Support legislation and opportunities to improve transportation, including, but not limited to, improving traffic safety, reducing congestion, curb management, electric vehicle charging infrastructure, repairing local roads and highways, expanding trail networks, and supporting noise abatement for properties near freeways.
3. Support the inclusion of affordable housing development as an allowable federal infrastructure purpose to promote economic mobility, provide greater household stability, and improved wellness outcomes.
4. Support appropriate annual funding levels of the Mid-Coast Corridor per the Full Funding Grant Agreement, as well as efforts to reinvest any federal funding savings to benefit the corridor.
5. Support funding, programs, partnerships, and policies that promote active transportation connectivity to mass transit to address first and last mile gaps.
6. Support existing and expanded funding targeted for allocation to local and regional mass transit and transportation infrastructure.

7. Support legislation and administrative action that increases funding and flexibility in both operations and capital funding for mass transit and active transportation including, but not limited to: regional bicycle and pedestrian mobility and accessibility projects; zero emission vehicle adoption and electric vehicle charging infrastructure; youth passes; e-bike incentives; autonomous and connected vehicle technology; transit only lanes; expanding trail networks, safety, such as Safe Routes to School and Vision Zero; airport connectivity; and infrastructure improvements.
8. Support Vision Zero programs and prioritization of discretionary funding to cities that have adopted Vision Zero initiatives.
9. Support legislation and programs that provide funding to improve local and regional bicycle and pedestrian mobility networks and accessibility, including accessibility in city facilities like parks and libraries.
10. Support existing and expanded funding opportunities for local and regional transportation infrastructure.
11. Support retaining and expanding the Infrastructure for Rebuilding America (INFRA), Capital Investment Grants (CIG), and the Better Utilizing Investments to Leverage Development (BUILD) grant programs and advocate for measures to enhance the City's competitiveness in seeking funding.
12. Support the Transportation Infrastructure Finance and Innovation Act (TIFIA) program.

4. Support legislation that facilitates and funds incubators, accelerators, and co-working spaces, as well as efforts that support the employee-owned business model, including providing incentives to hire locally in key innovation industries.
5. Support legislation to boost the City's prominent craft brewing industry.
6. Oppose legislative and regulatory mandates imposed on the City's innovation economy.
7. Support measures that enhance local control to promote and regulate healthy and safe street vending operations.
8. Support legislation and programs that support the development and sustainability of microenterprise businesses, including microenterprise home kitchen operations, microenterprise home-based childcare operations.
9. Support legislation that supports the development and utilization of Community Development Financial Institutions (CDFIs).
10. Support legislation to add fusion energy as a clean energy technology.

Federal

1. Support funding and proactively pursue participation in new federal agency initiatives relevant to growing San Diego's industry clusters, such as biotechnology, life sciences, high tech, advanced manufacturing, sports and active lifestyle, digital economy, clean tech, blue tech, and cyber security.
2. Support legislation to provide direct incentives and/or ease barriers to private funding for companies, public-private partnerships and other entities engaged in research, development, and commercialization of key innovation industry clusters.
3. Support resources and the promotion of the City as an industry leader as part of its participation in the Federal Aviation Administration (FAA) UAS Integration Pilot Program through the establishment of a clear regulatory environment.
4. Support legislation and funding for research and development of cybersecurity requirements for UAS.
5. Oppose legislative and regulatory measures that preempt local control over the implementation and utilization of autonomous vehicle technology.
6. Support a strong patent system that drives innovation, protects and values the enforceability of patents, stops the diversion of fees from, and fully funds the U.S. Patent and Trademark Office (USPTO).

Support federal research and oppose funding and incentive cuts to critical to San Diego clusters, research institutes, and local universities from such sources as the National Institute of Health (NIH), National Science Foundation (NSF), U.S. Department of Energy, Small Business Innovation/Technology Transfer programs, NAVWAR, SSC-Pacific and other U.S. Department of Defense agencies.
